Holiday – Public Holiday on 19.12.2023 (Tuesday) for the Districts of Tirunelveli and Thoothukudi declared under Negotiable Instruments Act, 1881 – Orders – Issued.

**ORDER:**

The cyclonic circulation in the lower tropospheric levels over equatorial Indian Ocean and adjoining southwest Bay of Bengal off south Sri Lanka coast is now seen over Comorin area and neighborhood extending up to mid tropospheric levels. Under its influence isolated heavy to very heavy rain with extremely heavy rain is likely over south Tamil Nadu on 19<sup>th</sup> December. In view of the above, the Government has decided to declare Public Holiday on 19.12.2023 (Tuesday) under the Negotiable Instruments Act, 1881, as a special case.

2) The Government accordingly issues the following orders:

- i) All Government offices including the offices of Public Undertakings / Corporations, Boards, Banks, Financial Institutions etc., in Tirunelveli, and Thoothukudi will be closed on 19.12.2023 (Tuesday).
- ii) However, all essential services, such as Police, Fire Service, local bodies, milk supply, water supply, hospitals / medical shops, power supply, transport, fuel outlets, hotels / restaurants, etc., and the offices engaged in disaster response, relief and rescue activities shall function as usual.

3) Accordingly, the following notification will be published in the extraordinary issue of the Tamil Nadu Gazette on 19<sup>th</sup> of December 2023.

The cyclonic circulation in the lower tropospheric levels over equatorial Indian Ocean and adjoining southwest Bay of Bengal off south Sri Lanka coast is now seen over Comorin area and neighbourhood extending up to mid tropospheric levels. Under its influence isolated heavy to very heavy rain with extremely heavy rain is likely over south Tamil Nadu on 17<sup>th</sup> and 18<sup>th</sup> December. In view of the above, the Government has decided to declare Public Holiday on 18.12.2023 (Monday) under the Negotiable Instruments Act, 1881, as a special case.
